### Candidate Bios for 2024 Slate

Position: Director (2-year term), up for election in 2026

Recommended Candidate: Dave Guebert

Dave has served with the Hockey Calgary Board since 2022. He has been a valued member for our Audit and Finance committee, a natural fit for his professional background as a CPA. Dave has had previous volunteer experience in hockey as a long-time member, and former president, of the McKnight Hockey Association.
